Removing the Clean Car Discount Scheme by 31 December 2023

The Cabinet paper sent on Thursday 30 November 2023 reflects your discussions with officials with the most significant change being to achieve a clear end-date through:

- charges ending for all vehicles registered after 11:59 pm on 31 December 2023
- rebate applications being accepted until 11:59 pm on 31 December 2023
- all rebate applications being processed by 31 January 2024.

NZTA has confirmed it will prioritise staffing and systems to support the 31 January 2024 processing deadline.

Following Cabinet's consideration of the paper on Monday 4 December 2023 the remaining steps to secure legislation to repeal the Clean Car Discount are in the table below.

The Ministry's advice includes draft letters for you to send to NZTA and Councils advising them of the Government's intention to withdraw and seeking mutual agreement to close the programme (so that a 3-month process, under the current RFA, does not need to be initiated).

MV Rangitata

Ships operating around the New Zealand coast must comply with international conventions (for foreign flagged vessels) and domestic laws (for New Zealand flagged vessels). They must also work with their classification society (a non-government organisation that establishes and maintains technical standards for the construction and operation of ships and offshore structures) to maintain their vessel safety. Maritime NZ inspectors inspect and audit vessels for compliance with standards and can upon identification of deficiencies make corrective orders or detain vessels. We also investigate issues.

A detention notice was issued on the vessel *MV Rangitata* by Maritime NZ in early November 2023, after the vessel experienced engine issues and was towed into CentrePort. Since then, the vessel has been berthed at Wellington's CentrePort, it has been inspected by its classification society and undergone sea trials. Maritime NZ is considering options allowing the *MV Rangitata* to depart Wellington, under detention, to a dry dock in Auckland for repairs. If agreed, the voyage will be made either under tow, or under the ship's own power with escort by a tug (*MV Christine Mary*, 22 metres long, 122 GT). Towage plans and escort plans will be reviewed to ensure this voyage can be undertaken safely, and an updated detention notice will be issued to account for these plans once finalised. Maritime NZ expects to have a further update in the next few days around the timing of departure from Wellington and expected arrival in Auckland. A Maritime NZ investigation is underway.

We have prepared separate advice for you this week that outlines national level Emergency Towing current state capability as well as future capability options for your consideration. We will be available to discuss these with you. We have also in a previous briefing outlined current issues with numbers of Maritime Inspectors.

Recreational craft harm prevention

This summer an educational programme will be delivered to recreational craft users across the motu via the Safer Boating Forum (SBF). The national behaviour change campaign, Kia Mataara, will continue to run and remind recreational craft users to; always wear a life jacket, check the marine weather forecast and carry two water proof ways to call for help. We have been evaluating the Kia Mataara campaign as we go and the campaign to date has had positive impact. During summer a partnership with Harbourmasters across the country will see compliance activities taking place to check in on recreational craft users. Proactive media stories will also remind recreational craft users of what they need to do to stay safe.

The Recreational Harm Prevention programme aims to keep people safe on the water by reducing deaths and serious injuries to people on recreational craft. Approximately 2 million people participate in recreational craft activities every year. On average, 18 people die every year on recreational craft. The victims of these accidents are overwhelmingly males over the age of 45 years. The majority of deaths occur on craft 6m and under and are due to not wearing a life jacket or to wearing an incorrectly fitted life jacket.

Maritime NZ delivers a range of educational activities via SBF members. The SBF is a network of 26 national and regional government agencies, local body groups, boating organisations and the marine industry involved in promoting recreational boating safety in Aotearoa New Zealand.

Maritime NZ in the media

Radio NZ became aware of issues around the *Rangitata*, a coastal shipping vessel. It then made enquiries about *Rangitata* and also about Maritime NZ's ongoing work for emergency towage capability. The reporter was informed that the *Rangitata* has been berthed at Centreport in Wellington since 4 November 2023 after experiencing engine issues, and it will remain under detention until all repairs and inspections are completed and conditions for release are met (see above). The information around the *Rangitata* supported a Radio NZ story about emergency towage capability, especially in Cook Strait. The piece featured commentary from Marlborough and Wellington Councils about the need for there to be emergency ocean-going towage capability and that they would be raising this, and the need for Maritime NZ to have more inspectors for prevention activity, with the new Government.

Key updates

Civil Aviation Authority (the Authority) Pricing Review

The Authority is undertaking a review of the rates set for its fees, levies, and charges. Due to the impact of the pandemic, the Authority has been reliant on Crown Funding to deliver core statutory functions since 2020. Current rates have not been adjusted since 2017 for safety functions and 2019 for most security functions. The previous Government directed the Authority to undertake a review to enable its return to a greater level of financial self-sufficiency and thus reduce its dependence on Crown funding.

The Authority is committed to reducing reliance on Crown funding as soon as practically possible. You will receive further briefings on this matter from the Authority and the Ministry of Transport in due course.

Reduced and Zero Emissions Project

In March 2023, the Authority initiated the Reduced and Zero Emissions (RZEP) project to coordinate regulatory effort needed to enable the introduction of aircraft with alternative propulsion and energy systems. Such systems are an alternative to traditional aviation fuels and would lead to a reduction in aviation's carbon footprint.

This project has been structured to support any airline, innovator or aviation operator by helping them to understand the regulatory pathways available to bring this type of capability into New Zealand.

Air New Zealand is exploring the use of alternative propulsion and energy systems. They are seeking to introduce an aircraft with alternative propulsion into commercial operations (initially cargo) from 2026. This is an aggressive timeframe for the introduction of a new aircraft and our RZEP team has been working closely with Air New Zealand and the relevant parts of the Authority ensure both parties are 'regulatory ready' — the intention being to provide Air NZ with a clear pathway for the necessary approvals (e.g., providing the documentation needed, clarity as to which civil aviation rules will apply, clarity as to what regulatory decisions from other aviation regulators can be relied upon, etc) and for the Authority inspectorate to be well prepared to make good regulatory decisions quickly.

As part of this process, we will be supporting Air New Zealand making an announcement about the aircraft it intends to use on 6 December 2023 in Auckland. Authority staff will participate in the panel that Air New Zealand has assembled to meet the media.

The RZEP contributes to the Transport element of New Zealand's Emissions Reduction Plan, and is aligned with the Zero Carbon Act.

Aviation security queues at Auckland International Airport

On 26 November 2023, passengers experienced queues and longer-than-usual wait times at the international security screening point at Auckland International Airport. The queues caused both frustration for passengers, airlines, and Authority staff, and gained media attention.

The Authority is very much aware of the need to ensure facilitation through the security screening process is efficient as possible while not compromising the security standards required for international (or domestic) flights.

Contributing factors to the queues on 26 November relate to an increase in US operators and US bound flights, accompanied by changes in passenger presentation and cabin baggage behaviours, compared to the norm, and unusually high aircraft loadings. Specifically, this included:

- A change in the profile of when passengers present for screening (much earlier), compared to planning assumptions, driving lane openings, and staffing levels.
- More passengers (due to very high aircraft loadings) compared to the planning assumptions, driving lane openings, and staffing that is based on the information provided by the airlines.
- More carry-on bags per passenger than planning assumptions, which increased the number trays and images to be screened and slowed throughput.
- Some staff who were less experienced – reflecting a systemic issue that exists in many parts of the aviation system post COVID-19 relating to newer staff, possibly impacting the speed of processing the increased passenger and bag numbers than ideal.

The event has been thoroughly reviewed and we are engaging with stakeholders on measures to prevent this from happening again. Follow up information has been provided to media contacts to give a broader understanding of the operating challenges, and actions to manage them, in the system. Further briefings will be provided to you on the issue of queues in due course.

The Civil Aviation Authority notified the Commission on 5 October 2023 of an incident involving two aircraft conducting night circuit flying at Ardmore Aerodrome on 3 October 2023 at about 2125 hours.

The circumstances reported to date are that while conducting circuits and on short finals a Beechcraft Duchess BE76 (registered ZK-JED) was intending to conduct a touch-and-go and passed approximately 20 feet overhead of a Cessna C172 (registered ZK-WFS), that was intending to land. ZK-WFS commenced a go-around and then landed safely. There was no collision, no damage, and nobody was injured.

The Commissioner has opened an inquiry under section 13(1) of the TAIC Act 1990 and appointed Graham Thomas as Lead Investigator. They will be supported by Ian McClelland.

Notice of a new rail inquiry RO-2023-105 opened by the Commission on 9 October 2023

The New Zealand Transport Agency notified the Commission on 9 October 2023 of a derailment involving a tamper vehicle that occurred on the North Island Main Trunk Line near Glen Innes at about 0025 hours this morning.

The circumstances reported to date are that a tamper group were travelling to a work site when they entered Purewa Tunnel where rail had been removed. The first tamper machine derailed, with no injuries reported.

The Commissioner has opened an inquiry under Section 13(1) of the TAIC Act 1990 and appointed Dave Manuel as investigator in charge. They will be supported by Jason Lawn.

National Land Transport Fund revenue in the Half Yearly Economic and Fiscal Update (HYEFU)

The Treasury will publish HYEFU 2023 on 14 December 2023.

HYEFU 2023 will report that anticipated revenues to the National Land Transport Fund (NLTF) over the three years covered by GPS 2024 will be \$125 million less than anticipated in the Pre-election Economic and Fiscal Update (PREFU). Only approved tax increases are included in Economic and Fiscal Updates.

The main reason for the difference between the two forecasts is that Treasury are anticipating that crude oil prices will be 17 percent higher in 2024 than forecast in PREFU.

Total net NLTF revenues and the difference between PREFU and HYEFU are summarised in the following table.

Difference	-\$171.34m	\$37.78m	\$8.46m

Most of the variation is concentrated in the first year, amounting to 4 percent less NLTF revenue in 2024. A reduction of this scale in a single year is material. However, over the three years of GPS 2024 forecast revenue is just one percent down on PREFU. A one percent difference in forecasts is not significant and within the normal bounds of variability between consecutive Economic and Fiscal Update forecasts.

Increased demand for driver licence testing	<p>On 1 October 2023, driver licence fees changed to an all-in-one fee for each stage of a driver licence. In addition, fees to re-sit a driver test, or to cancel or reschedule a test, were removed.</p> <p>Since then, the Automobile Association (AA) and Vehicle Testing New Zealand (VTNZ), who provide driver licensing services on behalf of NZTA, have seen increased demand for driver licence tests.</p> <p>For example, in June 2023, NZTA received 30,633 practical test booking requests (both restricted and full licence tests). In October 2023, after the new fees went live, practical test booking requests were 58 percent higher than in June 2023, at 48,535. In November 2023, this figure fell back to 46,575, but still remains 52 percent above June 2023 figures. This increase in demand is currently increasing the time people are waiting to sit their practical tests. The average wait time for practical tests has increased to above the VTNZ key performance indicator of 30 days in all regions (as high as 91 days for restricted tests in the Auckland Northwest region).</p> <p>Additionally, theory test bookings increased from 16,755 in June 2023, to 24,787 in October 2023, representing a 48 percent increase. In November 2023, this increased further to 25,442, 52 percent more than June 2023. There has also been a significant increase in the number of people taking a theory test more than once a day.</p> <p>More analysis is underway to understand the drivers and impacts of this increased demand, including whether the change in fees is leading to higher levels of non-attendance at scheduled tests and changes in pass/failure rates. This analysis will inform necessary changes to manage wait times. NZTA will provide this analysis to you in future updates. In the interim, NZTA is working closely with AA and VTNZ to ensure it can reduce the impact of demand on people wanting to sit their licensing tests.</p>
Auckland Urban Programme	<p>Auckland Council, Auckland Transport and NZTA have been working in partnership to develop an Urban Programme (the Programme) to deliver on a key initiative in s10.1.2 of the Emissions Reduction Plan to 'design programmes to reduce total light fleet VKT in our largest cities'. The Programme provides an integrated view of the land use and transport planning, policy and investment changes required to optimise the wider Auckland Transport system. This work is now complete and will be presented to the Auckland Transport Alignment Project in mid-December 2023, with papers relating to the programme being publicly accessible from 7 December 2023.</p>



	<p>The Programme provides an evidence base of packages and interventions to deliver efficiencies largely utilising/repurposing the existing system and reducing congestion across the network while also having the potential to defer large costly infrastructure projects and deliver wider benefits including emissions reduction, equity and health benefits.</p> <p>The initial cost estimate is \$20.4bn capital expenditure. This estimate includes expenditure for committed work programmes and provides for improvements across most of the existing urban area (not just one corridor). The Programme does not commit any implementation funding, but it can be used to inform planning processes such as the Auckland Integrated Transport Plan. Next steps will be to identify which projects and initiatives would most benefit from integrating insights from this work and complete further analysis to understand any additional cost that would be required to deliver the outcomes.</p>
SmartTrip road pricing – NZTA submission on the Tauranga City Council draft 2024-2034 Long Term Plan	<p>Tauranga City Council (TCC) is leading work on SmartTrip – a variable road pricing charge to reduce congestion and fund transport improvements. NZTA co-funded and co-governed the investigation along with TCC. As part of their draft 2024 Long Term Plan, TCC is seeking public feedback on whether to “work with NZTA and Government to further investigate SmartTrip through a business case investigation.”</p> <p>Under current settings, TCC is not permitted to introduce place-based road pricing. NZTA will make a submission in support of TCC exploring a form of place-based road pricing through a business case investigation. Although it is not usual practice for NZTA to make a submission on Long Term Plan's, it has an interest in supporting local inquiry into the efficacy of transport interventions, including forms of economic pricing. As part of the submission, NZTA will be endorsing the value of using all appropriate intervention levers, including economic pricing, to improve the performance of networks and services and manage travel demand, not specifically endorsing SmartTrip.</p> <p>NZTA will also be inviting TCC to work with it, the Ministry of Transport and other interested councils (such as Auckland Council) to support a nationally consistent approach to investigating and implementing variable pricing. Submissions are due to TCC by 15 December 2023 with public hearings in February 2024.</p>
Te Ara Hauāuru - Northwest Rapid Transit	<p>The public feedback summary, from the first phase of engagement, was published this week and emailed to submitters and stakeholders. Nearly 4000 people completed the consultation survey as part of the first phase of engagement, with 93 percent of people expressing support for rapid transit in the northwest.</p>

National Māori action day protests	<p>On 5 December 2023, protest marches and convoys were held around the country in response to the Te Pāti Māori call for action against the new government's policies on co-governance and the Treaty.</p> <p>Police led the operational planning and response to the protest activity with NZTA in support, as there was potential to cause significant congestion, disruption and delays on key highways and arterial routes across many towns and cities across the country.</p> <p>During the protest activity, both the NZTA and Auckland Transport transport operations centres monitored and supported in real-time, with the biggest delays to the transport network seen in Auckland. As Police anticipate further protest activity, and that it may escalate in scale in the future, NZTA will continue supporting Police in their operational planning and response.</p>

Engagement with communities to update people on investigations and share a preferred option will happen next year.
Auckland/Northland - Ara Tūhono – Pūhoi to Warkworth	A media release is being planned for distribution during the week beginning 11 December 2023 following the motorway being open for six months, highlighting that its safety features have already prevented potential head on crashes as well as journey time savings.
Waikato/Bay of Plenty – State Highway 2 Baypark to Bayfair Link	A media release will be issued on 15 December 2023 celebrating the pou whenua installation and blessing at the SH2 Baypark to Bayfair Link. As part of the project, 3 x 6 metre mahi toi (artworks) will be installed at the State Highway 29A roundabout next week.
Waikato/Bay of Plenty - Hewletts Road rail crossing	A media release will be issued on 15 December 2023 marking the completion and blessing of the safety improvements to the Hewletts Road rail crossing in Tauranga with the installation of a paved and fenced pedestrian maze and additional fencing to prevent crossing at other areas along the track.

**Rangitata**

A coastal shipping vessel that was detained in early November 2023 after experiencing engine issues has this week arrived in Auckland to be repaired at a dry dock.

On 4 December 2023, the cargo vessel *Rangitata* arrived and docked in Auckland, four days after it departed Wellington. It was escorted to Auckland by the *Christine Mary*, a 22-metre, 122 tonne towage vessel. Prior to the vessel departing Wellington, Maritime NZ was presented with a suitable passage plan, risk assessment, towage plan and a certificate issued by Class stating it was safe to be towed as required by the updated detention notice. These conditions were satisfied before its departure from CentrePort on 30 November 2023. The journey was made under the updated detention notice permitting the ship to undertake a single voyage from Wellington to Auckland for repair.

The vessel will now go to dry dock for repairs. Once these have been completed, the vessel will be re-inspected against the general conditions of the Maritime NZ detention order. It will need to satisfy these conditions as well as work with its classification society and satisfactorily complete a Maritime NZ safety management audit before it is able to return to service.

NB: A ship classification society is a non-government organisation that establishes and maintains technical standards for the construction and operation of ships and offshore structures.

Maritime in the media

On 1 December 2023, Maritime NZ put out a proactive media release relating to the sentencing of Ports of Auckland Limited in connection to the death of stevedore Pala'amo Kalati, who died in August 2020 after being struck by a container. The release accompanied the sentencing of POAL, after they pleaded guilty to charges in relation to the death, and an Adverse Publicity Order (which means that POAL publishes its guilt in relation to the matters widely to the public). We were pleased that POAL admitted responsibility for what occurred and the reparations and actions they have undertaken in response. Our media release was an opportunity not just to talk about the risks of port work, and that we were pleased for closure for the victims, but also to talk about the improvements that have occurred within the sector since the Port Health and Safety Leadership Group was stood up 20 months ago, and to recognise that POAL has been active in this work. The content was picked up by multiple mainstream media outlets and they conveyed the messages Maritime NZ put forward.

On 27 November 2023, Lyttelton Port Company (LPC) pled guilty to a representative charge under the Health and Safety at Work Act 2015, in relation to the death of Donald Grant on 25 April 2022. Mr Grant died after he was struck by coal while it was being loaded into a vessel's hatch. This week, Newsroom reporter David Williams requested an update from the 27 November hearing. We confirmed to the reporter that LPC had pled guilty, and its sentencing date is 5 March 2024.

On 30 November 2023, we updated media about a decision to file charges against the skipper of a recreational vessel involved in a collision with ferry in Russell during April 2023. This was a high-profile incident at the time, the ferry's skipper was severely injured and other passengers suffered lesser injuries. The ferry sunk a few hours after the collision. This media release was widely picked up by mainstream media outlets.

As more people are getting out and undertaking outdoor activities, we are seeing an increase in media requests around rescues coordinated by Maritime NZ's Rescue Coordination Centre New Zealand. Over the last week we have provided comments on two rescues that occurred in Mt Aspiring National Park. One which saw two climbers needing to be airlifted off the mountain. Another where a trumper injured their ankle and was airlifted to hospital with the other member of their tramping party. We took opportunities with both stories to reiterate the need for trampers and climbers to carry beacons in case they need to call for assistance.

Key updates

Meeting with the Authority on 5 December 2023

Janice Fredric (Chairperson of the Authority), Keith Manch (CEO) and Mark Wheeler (General manager of AvSec) met with you on Tuesday 5 December. We appreciated this useful opportunity to discuss a range of critical civil aviation matters and thank you for making time available. We agreed to follow up on a number of actions which we will address as soon as possible:

- Providing you with regular reports on Aviation Security queues
- Preparing a briefing on the ICAO security audit, the findings, and our progress in addressing the findings
- Providing you with a briefing on the Authority Pricing Review. The briefing will give an overview of the background and rationale of the review, the cost drivers and the options we have considered, along with future timelines. This will include specific information about the way in which emerging technology activity can or could be funded

We welcome your interest in sector engagement opportunities, and we invite your office to engage with us before Christmas to make arrangements for any such opportunities that might interest you. For example, we may be able to arrange a visit to an AvSec station and airport for an in-depth insight into aviation security. We will also extend an invitation through your office to the first Aviation Security Stewardship Group next year.

Regulatory Stewardship and Civil Aviation Rules

Regulatory stewardship refers to action to ensure that all elements of the regulatory system are 'fit for purpose' in achieving the outcomes desired from that regulatory system. This specifically includes ensuring that the regulatory requirements that are imposed on the aviation industry are 'fit for purpose'. The Briefing for the Incoming Minister we provided to you noted the following on page 34.

Some rules are overly prescriptive and have become out of date, and others are structured in a way that is not well aligned with modern regulatory practices. Aside from creating both aviation safety and legal risks, this can create an increased regulatory burden on the aviation sector and hinder innovation. Rapid changes in technology across the sector require a flexible and responsive regulator, and good regulatory stewardship is critical to achieving this.

We would welcome the opportunity to discuss the possibility of changing the way the Civil Aviation Rules are made and/or amended in a way that is more responsive, enables better collaboration with the sector, and results in better outcomes aligned to the purposes of the current and future Civil Aviation Acts.

We would be happy to engage further on this with you if you wish.

Emerging Technology

There were two milestones for emerging aviation technology this week:

- Wisk Aero announced a successful trial flight of a remotely piloted aircraft in mainstream airspace near Christchurch. This is a first in New Zealand; Previously remotely piloted aircraft have had to fly in specially designated airspace away from other traditionally piloted aircraft.
- Air New Zealand have announced the aircraft they have chosen for their reduced zero emission programme, which we mentioned in last week's report. It is a battery powered electric aircraft (BETA's Alia CTOL).

As mentioned in last week's report, Authority staff were part of a Panel to meet the media and we were able to share our role in the process.

New Southern Sky programme comes to a close

The New Southern Sky (NSS) programme comes to a close on 31 December 2023 after a decade of effort. NSS, launched in 2014 by then-Minister of Transport, Gerry Brownlee, is a programme to modernise New Zealand's airspace and air navigation systems through the implementation of the Cabinet directed National Airspace and Air Navigation Plan. The over 50 projects and tasks as part of NSS have delivered major regulatory and infrastructure changes. The changes have brought about safety, environmental and efficiency benefits for the New Zealand aviation system as a whole.

A comprehensive Benefits Report will be tabled at the final Governance Group meeting on 12 December. The Governance Group comprises the Authority as programme lead, Airways NZ, the Ministry of Transport, and supported by an independent commercial barrister.

**New inquiries / International Assistance**

A new aviation inquiry, A0-2023-012 was opened by the Commission on 27 November 2023.

The United Kingdom Air Accidents Investigation Branch (AAIB) notified the Commission of an accident that occurred at about 1407 on the 22/08/23 (UTC) near Enstone, Oxfordshire, involving a Spitfire MK 26B. The circumstances reported are that the Spitfire, registered G-CLHJ, struck the ground during a test flight. The aircraft was destroyed, and the pilot did not survive the accident.

The Chief Investigator of Accidents has opened an inquiry under Section 8(2)(e) of the TAIC Act to support the AAIB investigation and appointed Ian McClelland as Investigator in Charge.

New Zealand Council of Cargo Owners (NZCCO)

We understand that you recently met with representatives of the New Zealand Council of Cargo Owners (NZCCO) and asked the Ministry for information on how officials (including Maritime NZ) engage with them. The Ministry will brief you separately on their engagement through the Freight and Supply Chain Strategy process.

Maritime NZ has a productive working relationship with the NZCCO. Engagement is focused on specific matters of interest. In addition, Charles Finny, the convenor of the Port Chief Executive roundtable, represents their interests at a monthly meeting we convene with members of the wider maritime sector (the Maritime Industry Forum). We have agreed with NZCCO that we will connect in the new year to identify whether there are areas that require more direct connection.

In engagement with NZCCO, we understand their priority concerns currently are emissions policy, green shipping corridors and port productivity. This reflects their 'manifesto', shared with you.

We understand that the Ministry's briefing will address many of their priorities. One additional matter that NZCCO and Port CEs have raised in relation to their priorities is the need for New Zealand to have a permanent presence in London focused on the International Maritime Organisation (IMO). The most influential states at the IMO have permanent representatives in London who regularly meet and work with the secretariat to progress work. Such a position could enhance New Zealand and the Pacific's interests. We are happy to brief you further on this matter if you wish.

Fatal accident near Waiheke Island

On Thursday 7 December 2023 at about 1pm, two people (one adult female and one adult male) departed Maraetai Beach in a modified Parker Craft dinghy intending to go fishing in the channel. At about 3.30pm, while at anchor and fishing, the vessel started to take on water and sink and both parties entered the water. The female was wearing a life jacket, while the male had chosen not to wear his life jacket but was able to hang on to it when the vessel sunk under them.

The vessel was submerged and remained in place at anchor. The couple decided to swim to shore in conditions that were described as difficult. After about 3 hours of swimming the male likely drowned and the female survivor was recovered later that evening in her life jacket. ^{s 6(c)}

Sentencing of Sealord after crew exposed to asbestos

Seafood company Sealord pleaded guilty and has been fined \$257,250 in the Nelson District Court and ordered to pay \$3000 emotional harm reparation to two crew members, following an investigation and prosecution by Maritime NZ.

The company was also ordered to pay legal costs of almost \$30,000 on a charge that carried a maximum fine of \$1.5 million. Judge Zohrab also asked that Sealord communicate the lessons it had learned through this to the Fishing Health and Safety Forum and communicate this to Maritime NZ once it has done so.

Sealord was sentenced for failing in its duty of care, by allowing its workers to be exposed to asbestos while working on-board the fishing vessel *Will Watch* in 2021. At the time the exposed asbestos was reported, the vessel was operating out of Mauritius and New Zealand-based Sealord employees were being seconded to work on it. While crew were seconded from Sealord, they were subject to the terms and conditions of their New Zealand employment agreement.

Sealord initially argued that there was no case to answer as the vessel was not owned by the company and therefore considered it was excluded from the Health and Safety at Work Act, but subsequently changed their plea to guilty.

Maritime NZ in the media

The focus of media over the past week has been around recreational craft activities leading into summer and rescues coordinated out of Maritime NZ's Rescue Coordination Centre.

The Wairarapa Times Age requested information about recreational craft activities in the area for summer and what the risks were. We decided it best to direct the reporter to Greater Wellington as the authority with harbourmaster responsibilities for the region. However, we took this opportunity to promote the speed rules for users of the Ruamahanga River. Earlier this year new signage went up along the river to help users better understand the speed rules for the river.

Late last week, two climbers were airlifted from Malte-Burn in Aoraki/Mt Cook National Park. The climbers got themselves into difficulty and the DoC Mt Cook Alpine Cliff Rescue Team were helicoptered in to their location to help get them to safety. We also took this as an opportunity to promote safety messaging encouraging people to carry beacons, understand the conditions and think how to prepare for outdoor trips.

The sentencing of Sealord, outlined above, has also been reported in the media.

Cancel Auckland Light Rail

On Monday 18 December 2023, Cabinet met to confirm your proposed approach to cancelling the project [CAB-23-MIN-0496 refers]. We provided a briefing for shareholding Ministers seeking agreement to the subsequent actions needed to give effect to Cabinet's decision.

Over January 2024, Auckland Light Rail Ltd's wind-up process will begin. In early January, the new, smaller Board will meet to formally start the wind-up process.

In January 2024, the Ministry will also be starting a due diligence process on the company's contracts, obligations and liabilities to give us a comprehensive view of ALR Ltd's position.

Construction for the Tancred Crescent and SH6 intersection (access to the Marlborough Airport) will be confirmed in early 2024.
Te Ara Tupua – Enhanced Offshore Reef (Wellington)	<p>Te Ara Tupua, the walking, cycling and resilience project between Ngauranga and Petone, has resource consent conditions which require mitigation of the environmental impact of reclamation into Wellington Harbour. The consent conditions require delivering one of two alternative initiatives to improve habitat and water quality.</p>

Maritime NZ services continue during holidays

Maritime NZ's services will continue while our offices are closed to the public from Saturday 23 December 2023 to Sunday 7 January 2024.

The Rescue Coordination Centre NZ (RCCNZ) and the Maritime Radio Service operations rooms, which are located next to each other, are staffed 24/7 every day of the year. Summer is our busiest time – this has already been our busiest year on record and we have rostered staff accordingly. We have logged 1,300 search and rescue (SAR) tasks for 2023 so far (the previous busiest was 2022 with 1,257) and we are likely to get close to 1400 by end of December. Additionally, these numbers do not include the 256 tasks we undertook during the Cyclone Gabrielle response, rescuing 450-600 people.

RCCNZ is responsible for coordinating all major maritime and air SAR missions and all missions arising from someone activating a distress beacon in New Zealand's 30 million square kilometre SAR region, from the South Pole to near the Equator. Maritime NZ is also responsible for providing maritime radio services to 50 million square kilometres of the south west Pacific known as NAVAREA XIV.

Similar to normal after-hours situations, Maritime Officers, Inspectors and Investigators are available to respond to maritime incidents if needed. Urgent licensing matters are still able to be processed, and our operational senior leadership is also available over this period with the main contact being our Deputy Chief Executive, Regulatory Operations.

In case of a major incident, Maritime NZ's duty response team is rostered 24/7 every day of the year. The team includes the Duty Incident Controller and Duty Senior Manager, who have standing delegations of the Director's responsibilities, and a Duty National on Scene Commander with authority under the Maritime Transport Act. The duty team has direct links to the National Response Team, local and central government agencies, other sector organisations and media.

The Recreational Craft Harm Prevention Programme increases activity in December and January when many New Zealanders head out to the water to enjoy the summer. The summer campaign uses radio, print, on-demand television, outdoor and digital media. This summer, it includes a partnership with Radio Hauraki, ad placements with MetService, Stuff, NZ Herald and Trade Me, and targeted ads on Facebook and Instagram to reach our target audience with three key safety messages: always wear a life jacket, take two waterproof forms of communication, and check the marine forecast.

Maritime NZ in the media

Maritime NZ will be issuing three media releases this week focusing on recreational craft safety. Summer and the holiday period is a high risk time for recreational craft users, and it is important for those planning to head out on the water to understand their obligations and risks.

On Monday 18 December, we received a request from an Otago Daily Times reporter about a jet boat collision on the Clutha River on 30 December 2022. We are confirming to the reporter this week that charges are going to be laid against a jet boating company and an individual.

Key updates

Next steps for Air New Zealand's zero emissions aircraft.

In the Weekly Report from Friday 8 December 2023, we indicated that Authority staff supported Air New Zealand's (Air NZ) recent announcement of the aircraft they had chosen for their zero emissions aircraft programme.

The aircraft is undergoing certification by the United States Federal Aviation Administration (FAA). The Authority is engaging with the FAA and will shadow the FAA's certification of the aircraft. This will allow the Authority to evaluate the aircraft at the same time as the FAA and will assist in meeting Air NZ's ambitious timeline and help reduce costs to both Air NZ and the Authority.

Authority Screening Data Update

We are working through how best to provide you with regular updates on screening data and performance. We will put regular updates in place early in the new year.

You are aware of the data that has been published on our website, with the last entry in June 2023. We will update that data shortly. We note that it is limited in its value as it is based on manual sampling of 30 people by location per month, and generally varied and random so we don't just look at quiet and busy times.

We are involved in piloting a Lidar (Light Detection and Ranging) remote sensing method to measure queues with Wellington Airport. This will provide accurate and timely data about queue performance. We will brief you more fully on this pilot in late January 2023 and the opportunities it provides for improvement of queue measurement across the system.

The management of staff and opening of lanes is modelled on a full range of passenger data and screening scenarios, and consulted with relevant parties to ensure adequate resourcing is available during the peak travel season. To meet challenges presented by staff vacancies and the impacts of the COVID-19 'fifth wave', the Authority has engaged 154 Load Assistants on short-term contracts to help manage passenger screening activity, and we have added extra capacity in order to reduce the risk of long queues.

Informed by this data (as an example), the Authority expects to operate at its full passenger screening capacity each day during periods where we expect peak passenger volumes. While the Authority resource modelling is for periods when we expect peak passenger volumes there is some, albeit limited, flexibility built into the rostering to address short notice changes to airline schedules. However, that flexibility is constrained ultimately by the total number of staff and lanes available.

We will provide a briefing to you in the second half of January 2024 with more detail about data and performance information that is available, and being developed, and would appreciate the opportunity to engage with you to determine what you would find most useful on a regular basis.

**New inquiries / International Assistance**

Notice of a new rail inquiry opened by the Commission on Monday 18 December 2023, for your information.

RO-2023-106 opened by the Commission.

NZTA notified the Commission this morning of an incident involving a KiwiRail passenger train (TranzAlpine) that had occurred at around 4:00pm on Sunday 17 December 2023.

The circumstances reported to date are that the train experienced a decoupling of carriages (parting) near Arthur's Pass while travelling from Greymouth to Christchurch. The train was reportedly carrying 54 passengers and 10 crew at the time. No injuries have been reported. The incident carriage was subsequently disconnected, and the train continued on its journey to Christchurch without further incident.

The Commissioner has opened an inquiry under Section 13(1)b of the Transport Accident Investigation Commission Act and appointed Jason Lawn as the lead investigator for this inquiry. Jason will be supported by Jeff Shearer.



NETWORK

Christmas holiday network maintenance in Auckland and Wellington

The Auckland and Wellington metro networks will be closed to commuter trains between 26 December 2023 and 15 January 2024. Freight trains will resume running on 5 January 2024. This is a standard closure every year, offering an extended period of uninterrupted access for project and maintenance work. This benefits all rail users, as major progress is made in maintenance and improvement work to support a reliable rail system.

Work in Auckland includes:

- Completing Stage 2 of Auckland's Rail Network Rebuild (RNR) on the Eastern Line, which has been closed since March 2023. AT's commuter services will resume on 15 January 2024. This is a major milestone as we ready Auckland for the City Rail Link.
- Progressing enabling works for the new 3rd Main Line around Middlemore Station and signalling upgrades at Wiri, as a step towards making the whole Wiri to Quay Park 3rd Main operational.
- Commissioning the new overhead lines between Papakura and Pukekohe, as part of the project to extend electrification to Pukekohe to unlock land use development in Auckland's southern corridor.
- Replacing rails, sleepers, and ballast (the rocks that sit around the tracks) at sites across Auckland as part of ongoing maintenance for a reliable network.
- City Rail Link teams are doing significant track and civil work at Waitematā Station, at Quay Park and some work at Newmarket.
- Slip repair work at a number of sites on the Western Line between New Lynn and Fruitvale.
- Doing major civil and drainage works on the inner part of the Western Line (New Lynn – Newmarket), as part of Stage 3a of the RNR.

Work in Wellington includes:

- Renewal work begins inside the Maoribank and Remutaka Tunnels, on the Wairarapa Line, to update the original track from 1955. An old wooden bridge (Bridge 56) near Matarawa will be replaced. Capacity-building upgrades will start with work on a passing loop at Woodside Station and the Fitzherbert St level crossing in Featherston.
- The complex re-signalling work at Wellington Railway Station will continue, alongside much-needed work on various tracks, foundations, and platforms. This project will improve safety in what is New Zealand's most complex railway junction.
- Work on the Kāpiti Line to complete the last major portion of the Plimmerton Station upgrade project. The upgrade includes adding a third track and platform at the station and will allow commuter trains that currently run from Wellington to Porirua to be extended to Plimmerton, helping with capacity at peak times. Bridge 23 (just north of Paekākāriki) will also be replaced.
- Maintenance work on the Hutt Valley Line, largely between Ava and Taitā Stations.

KiwiRail has issued press releases and stakeholder communications about the planned Christmas work, and we also have communications staff working over the Christmas holidays to answer any queries or complaints members of the public may raise.

If you would like to visit any of the holiday maintenance sites during the break, our team would be pleased to welcome you to site.

The Strand Station opening event

On 21 December 2023, KiwiRail will hold a blessing and opening event for the new station building in central Auckland. The new station is a KiwiRail initiative for travellers to check in and relax prior to boarding their Northern Explorer scenic or Te Huia train journey.

66 The Strand, a former railway signals building which dates from 1930, has been completely restored and renovated, adding modern features, such as a new café, waiting lounge and workspace area. It will provide thousands of passengers travelling between Auckland and Wellington each month with fantastic facilities, before they go and on arrival.

The New Strand building is available to Great Journeys New Zealand customers to check in for their Northern Explorer scenic train journey, guided tours, and for Te Huia passengers. It has a café, comfortable waiting area, toilets, and showers. Free WiFi will be available in the early part of next year.

INTERISLANDER**Summer season – forecasts and preparation**

Over the summer months, we are currently forecasting to carry around 258,000 passengers over 89,000 vehicles (December – February). This week (from 18 December 2023), we have just over 10,000 passengers booked to travel with us (10,124), and we are nearing capacity as we head into the busiest period of 23 December 2023 to 6 January 2024. The days just after Christmas from 27-29 December are looking likely to be our busiest days of the year.

To ensure we can offer travel options to passengers during this busy time, we have put on additional sailings from Picton leaving at 2:30am and sailings from Wellington leaving at 2:00am and 6:15am. We are also taking some bookings on what are usually freight-only sailings.

Interislander crews take pride in creating great customer experiences. Our message to the team is to focus on a professional and competent service to demonstrate our fantastic Interislander experience to customers. We have lifted our asset management and operational systems across 2023, in readiness for this peak and the coming years. Our team is focussed on the “big four”: safe, reliable, on time, with amazing customer service.

Safe On-Time Performance and Reliability

Customers care about Interislander on-time performance (OTP) and reliability.

We measure OTP based on a “safe on time customer journey” against the scheduled sailing timetable, and reliability based on sailings occurring as scheduled. In instances where we are using the Northern Entrance to the Sounds due to rough weather and safety concerns instead of the usual route through the Southern Entrance, it is a given that our expected sailing times are extended. In essence we are measuring our performance from a customer journey perspective and ensuring we are meeting their expectations.

The below shows the trend data for OTP and reliability:



- Reliability has been on target, however the time to repair the Kaiarahi disrupted sailings in mid-late November and has returned to target following the completed repair.
- OTP has been similarly impacted by the Kaiarahi outage during November, with weather disruptions affecting sailings in early October. In December we have recovered significantly and are running ahead of target moving into the busy holiday peak.

We benchmark ourselves against Air New Zealand, which averaged 75 per cent OTP during September 2023. So far, Interislander OTP has averaged 86.77 per cent during this financial year. Air New Zealand's most recent On Time Performance data, as published, is shown below:

3 UPDATES FROM TRANSPORT CROWN ENTITIES AND SOES

LONG DISTANCE PASSENGER TRAINS**Te Huia passenger numbers**

Te Huia operations have been reliable to date in December (19 December 2023) with no cancellations or bus replacements. The average daily passenger count has been 254 on weekday services and 199 on Saturdays, and 3,390 passengers have used the service so far in December.

Capital Connection

Capital Connection operations have been reliable to date in December (19 December 2023) with no cancellations or bus replacements. The average daily passenger count has been 482, and 5,298 passengers have used the service so far in December.

TRANZALPINE DECOUPLING

On Sunday 17 December 2023, the new luggage carriage we have added to the TranzAlpine decoupled from the end of the train just as it was arriving at Arthurs Pass. The luggage carriage does not carry passengers and there was no impact on our passengers. If a carriage separates from a train, the brakes on all carriages go on automatically.

As a result, we have removed this class of carriage – which includes the luggage and kitchen carriages used for our Scenic Plus service on the TranzAlpine and Coastal Pacific – so that they can all undergo a detailed inspection. Unfortunately, this means we have had to suspend our Scenic Plus service and are offering those passengers alternative bookings or refunds. We have apologised to them for the inconvenience.

There are no issues with any other carriages on the TranzAlpine and Coastal Pacific and both trains are running.

NZTA (as rail regulator) and TAIC have been advised of the incident, and we are investigating the cause.

We hope to identify and remedy any issue as quickly as possible so that Scenic Plus can resume.

UPCOMING MEETINGS/EVENTS

21 December 2023 – The Strand Station opening event – As above, opening event for the Strand Station. KiwiRail officials and local government officials attending.

Mid-January 2024 – RNR Stage 2 completed/Eastern Line reopened press release (with Auckland Transport).

Around mid-March 2024 – Auckland Train Control Centre opening event:

- This centre is important for Auckland commuter rail, particularly once the City Rail Link begins operating, and there will be more frequent commuter services in Auckland.
- It will see the relevant KiwiRail, Auckland Transport and Auckland One Rail teams working in the same premises for the first time – which will support more efficient operations/disruption management.
- We can hold an opening event which Ministers could speak at, followed by a tour of the centre (it has a large control room). Media will be invited.

Mid – late March 2024 – Hillside workshops (Dunedin) first wagon assembled.

- Event to mark completion of the first production wagon.
- Speeches followed by a tour of the facility, where there will be a series of wagons in different stages of assembly and meet staff. Media will be invited.
