**Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits
Duty) Amendment Order 2022**

Order

1 Title

This order is the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022.

2 Commencement

- (1) This order, except clause 5, comes into force on 15 March 2022.
- (2) Clause 5 comes into force on 15 June 2022.

3 Excise and Excise-equivalent Duties Table Amended

This Order amends the Excise and Excise-equivalent Duties Table (the **Table**) made under [clause 16\(1\)](#) of Schedule 3 of the Customs and Excise Act.

4 Temporary suspension and reduction of current rate of excise duty and excise-equivalent duty on motor spirits

- (1) In the Table, Parts A and B items relating to fuels, fourth column, the rate of “70.024¢ plus 8¢ per g of Pb” is suspended for the period beginning on 15 March 2022 and ending at the close of 14 June 2022.
- (2) In the Table, Parts A and B, items relating to fuels, fourth column, replace “70.024¢ plus 8¢ per g of Pb” with “45.024¢ plus 8¢ per g of Pb” in each place.

5 Current rates of excise duty and excise-equivalent duty on motor spirits reinstated on 15 June 2022

In the Table, Parts A and B, items relating to fuels, fourth column, replace, “45.024¢ plus 8¢ per g of Pb” with “70.024¢ plus 8¢ per g of Pb” in each place.

Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 15 March 2022, amends the Excise and Excise-equivalent Duties Table to effect a temporary reduction of motor spirits duty for a period of three months starting on the date of commencement.

This order is a confirmable instrument under section 122 of the Legislation Act 2019. It is revoked at the close of 30 June 2023, unless confirmed earlier by an Act of Parliament. That stated time is the applicable deadline under section 121 of that Act.
